Beck, J Judge Michel Part FB Proceeding TBA	Essence Ulmer	Ulmer, a toll-taker at the Bronx-Whitestone Bridge, is charged with Grand Larceny, Tampering With Public Records and Criminal Possession of Stolen Property, for collecting tolls for vehicles that went through her Cash lane, but entering them as eligible for cheaper tolls, allegedly pocketing the difference. Toll booth surveillance video captured her alleged wrongdoing between March and Sept. 2013.
